## **OTHER MATTERS**

## Rules 12(1) and 14(2)

There were issues in this election with candidates nominating for Sub Branches in TAFE Divisions for which they were not members. Most positions in the Tasmanian Branch Rules refer to "by and from" when referring to the electorate from which the position is elected. However Rule 12(1)(f) only refers to Sub Branch Secretaries, while Rule 12(1)(h) mixes 'sub branch' and 'sub branches' in the one sentence. Rule 14(2)(g) again mixes sub branch and sub branches.

Interpretation of the rules could be improved by including "by and from" in all positions when referring to the electorate.

## Rule 29(7)

This rule relates to candidate statements and there was an issue with the interpretation of this rule in respect of a statement, part of which a candidate thought constituted a "how to vote" card. Although the statement did refer to other candidates I did not consider it was a "how to vote" statement and I accepted the statement.

This rule could be tightened to specifically exclude references to other candidates without their permission.

This rule also specifies that candidates statements must be A4 size. If there are a large number of candidates and/or ballots this makes a large bulky and costly ballot material pack for mailing.

## ALLEGATIONS OF IRREGULARITIES RECEIVED

There were no written complaints or allegations of irregularities.

Arrangement for conduct of election.

. . .

[1] By decision dated 2 September 2009 [PR989009] I made arrangements under s189 of the Fair Work (Registered Organisations) Act 2009 for the election of a number of offices in the Tasmanian Branch of the abovenamed organisation.

[2] By decision dated 14 September 2009 [PR989255] I amended the decision of 2 September 2009.

[3] On 15 September 2009 I received a letter from the President of the Branch seeking a further amendment regarding the number of Delegates to be elected to the TAFE Division Council by the TAFE Division sub-branches.

[4] Rule 12(1)(h) of the Tasmanian Branch Rules provides as follows:

- 12(1) The TAFE Division Council shall consist of:-
  - (h) Delegates elected by and from members in TAFE Division Sub-branches elected on the basis of one Delegate for each 25 members or part thereof attached to the Sub-branch in excess of 25 members.
- [5] In my decision of 2 September 2009 this rule was interpreted as follows:

1 to 25 members – entitled to 1 delegate 26 to 50 members – entitled to 2 delegates 51 to 75 members – entitled to 3 delegates etc

[6] The request by the President of the Branch led me to reconsider my interpretation of sub-rule 12(1)(h). I have reinterpreted that sub-rule to mean that there must be more than 25 members of a TAFE Division sub-branch in order for an entitlement to arise for the sub-branch to elect a Delegate to the TAFE Division Council. Consequently, the rule should be interpreted as follows:

1 to 25 members – entitled to 0 delegates 26 to 50 members – entitled to 1 delegate 51 to 75 members – entitled to 2 delegates etc

[7] Accordingly, my original decision of 2 September 2009 and my amending decision of 14 September 2009 are amended as follows:

• By deleting the following offices:

Delegates to TAFE Division Council from the following Sub-branches:

Hobart (6) Clarence (2) Launceston (6) Devonport (3) Burnie (3) Drysdale (2)

• By inserting the following offices:

Delegates to TAFE Division Council from the following Sub-branches:


