

Statement: Prescribed Information: Section 189(1) of the RAO Schedule of the Fair Work (Registered Organisations) Act 2009

In accordance with Section 189(1) of the RAO Schedule of the Fair Work (Registered Organisations) Act 2009 and Regulation 138, I wish to lodge the following prescribed information in relation to elections which are required to be held for the Victorian and NSW Branches of the Australian Education Union for the undermentioned offices in this Union.

I am the Federal Secretary of the AEU and am authorised to lodge this prescribed information.

Victorian Branch

- (a) One (1) Federal Conference Delegate representing the General Division.
1 January 2013 - 31 December 2013.

Electorate: The electorate is the financial members assigned to the General Division of the Victorian Branch.

NSW Branch

- (a) One (1) Federal Conference Delegate representing the General Division.
1 January 2013 - 31 December 2013.

Electorate: The electorate is the financial members assigned to the General Division of the NSW Branch.

Reason for the Elections:

The Victorian Branch election is required to be held as a result of an increase of one delegate in the Victorian Branch entitlement to General Division Federal Delegates following an increase in the Branch's General Division membership at 30 June 2012 to 44,164. This gives the Branch an entitlement of 18 General Division Federal Delegates (the Branch currently has an entitlement to 17). (Federal Rule 24 (7))

The NSW Branch election is required to be held as a result of an increase of one (1) delegate in the NSW Branch entitlement to General Division Federal Delegates following an increase in the Branch's General Division membership at 30 June 2012 to 56,444. This gives the Branch an entitlement of 23 General Division Federal Delegates (the Branch currently has an entitlement to 22). (Federal Rule 24 (7))

Date and Times:

Federal Rule 24(8) states that "An election in accordance with the previous sub-rule shall be conducted using the same mode of election as is prescribed by these Rules for the election of Federal Delegates"

Federal Rule 30 (2) states:

"Subject to the next sub-rule, the elections shall be conducted in accordance with a timetable which permits the declaration of the election **on or before 31 October** prior to the date on which the Federal Delegates assume office."

Federal Branch Rules for the Victorian and NSW Branches contain respective timetables for the conduct of these elections.

Closure of the Roll of Voters

Federal Rule 30 (4) states that the roll of voters is to be closed seven days before the day on which nominations open.

Voting System

The voting system to be employed in the conduct of the elections for the offices is a direct voting system
