Arrangement for conduct of election.

- [1] On 24 January 2020, a decision was issued in this matter to arrange for an election for office arising from insufficient nominations.
- [2] Subsequently, on 2 June 2021 a decision was issued in another matter (E2021/73) arranging for an election for a new term of office. It has become apparent that this later election decision because it is an election for an entirely new term of office would have the practical effect of superseding the original decision in this matter.
- [4] As a result of communications from the Australian Electoral Commission (AEC), I understand that the election in this matter E2019/231 has not yet been conducted.
- [5] In circumstances where the election sought in this matter was for the filling of vacancies in what is now the previous term of office, and this has been overtaken by an election for a new term of office, I confirm that the AEC is no longer required to conduct election **E2019/231**.

- I, Susan Hopgood, being the Federal Secretary of the Australian Education Union make the following statement:
  - 1. I am the Federal Secretary of the Australian Education Union and am authorised to sign this prescribed information in relation to elections for delegates for AEU Federal Conference, National TAFE Council/Executive and Federal Office Committees due to be held in various branches of the Australian Education Union attached as Annexure A.
  - 2. I confirm that the following information is being lodged under subsection 189(1) of the *Fair Work (Registered Organisations) Act 2009*.
  - 3. These elections are required as a result of vacancies resulting from insufficient nominations received for various Federal Delegate positions in the recent AEU election E2019/32.
