1. I am the Federal Secretary of the Australian Education Union and am authorised to sign this prescribed information in relation to elections due to be held in all branches of the Australian Education Union.
2. I confirm that the following information is being lodged under subsection 189(1) of the *Fair Work (Registered Organisations) Act 2009*.
3. This statement is lodged at least 2 months before nominations open for the elections that are required.
4. **Voting system and number of positions**
