[2] The organisation's rules are such that the cut-off date for determining the number of various offices to be elected, by and from members of particular electorates, does not occur until either very close to or, in some cases, after the prescribed date in the *Fair Work (Registered Organisations) Regulations 2009* (the Regulations).

[3] Specifically, sub-regulation 138(3) of the Regulations requires that prescribed information for an election must be lodged at least two months prior to the date on which nominations are to open. The organisation's rules, in particular rules 24 and 47 require that the number of delegates shall be calculated according to the total number of financial members of the Branch as at 5pm local time on 30 June.

[4] These provisions have meant, in practice, for both the current election (**E2021/73**) and for the previous scheduled election (**E2019/32**), that the election decision has had to be issued with a significant number of offices not listing the specific number of persons to be elected.

[5] While the numbers to be elected are ultimately included in the call for nominations issued by the AEC, the rules as they currently stand necessitate further work by the AEC in order for this to be determined.

[6] Therefore, as part of the Commission's function of providing advice and assistance to registered organisations, I propose to separately engage with the organisation to discuss means by which the above issues may be able to be addressed before the next scheduled election is due.

[7] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

**Statement: Prescribed Information for Elections: Section 189(1) of the Fair Work  
(Registered Organisations) Act 2009 and Regulation 138 Fair Work (Registered  
Organisations) Regulations 2009**

I, Susan Hopgood, being the Federal Secretary of the Australian Education Union make the following statement:

1. I am the Federal Secretary of the Australian Education Union and am authorised to sign this prescribed information in relation to elections due to be held in all branches of the Australian Education Union.
2. I confirm that the following information is being lodged under subsection 189(1) of the *Fair Work (Registered Organisations) Act 2009*.
3. This statement is lodged at least 2 months before nominations open for the elections that are required.
4. **Voting system and number of positions**

The elections that are required are set out in the table in **Annexure A**. The voting system to be employed in the conduct of the elections for the offices is a direct voting system. Financial membership numbers for the General Division and TAFE Division as at 30 June 2021 will determine the number of positions for each office for each branch. In the case of the Aboriginal and Torres Strait Islander delegates the number of Aboriginal and Torres Strait Islander financial members in each branch as at 30 June 2021 will be the determinate. I will supply you with the number of financial members as at 30 June 2021 and the number of positions for each office for each branch as soon as they have been collected.

Your attention is also drawn to the provisions of Rule 24(3A), Rule 25, Rule 47(3), Rule 47A and various Branch Rules concerning the minimum representation of women in connection with any ballots that are necessary for the election of Federal Conference Delegates from the General Division and the National TAFE Council.

## 5. Dates and Times

Federal Rule 30 (2) states:

“Subject to the next sub-rule, the elections shall be conducted in accordance with a timetable which permits the declaration of the election **on or before 31 October** prior to the date on which the Federal Delegates assume office.”

Federal Rule 73, 74, 75 and 76 are the relevant Rules for the election of the Aboriginal and Torres Islander Education Committees (TAFE and General Divisions), National Principals’ Committee and National Early Childhood Committee members. The declaration of these elections must be **on or before 31 October** prior to the date the member takes office.

Federal Branch Rules for the various branches contain respective timetables for the conduct of these elections.

## 6. Closure of the Roll of Voters

Federal Rule 30 (4) states that the roll of voters is to be closed seven days before the day on which nominations open.

## 7. Rule Alterations

Federal Conference carried rule changes to Federal Rule 30(1) and added new SubRules 30(9) and 30(10) which relate to the election of the TAFE Division delegates representing the ACT, NT and TAS Branches. These rule alterations have been lodged with the Fair Work Commission. The proposed alterations were lodged on 26 March 2021.
