Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of contested and uncontested offices in matter E2018/242. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must, as soon as practicable after receiving the post-election report, publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission within **35 days of any changes** to the holders of office in the organisation. If there are no changes a notification is not required. If the election has resulted in any changes to the holders of office, the Australian Education Union-New South Wales Teachers Federation (NSWTF) Branch must notify the Commission of these changes. In particular, please advise:

- 1. Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
 - the name of the office now held;

- the date of the change of office holder;
- the name of the person now holding the office;
- the postal address of the person (generally the postal address of the organisation); and
- the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

[1] The decision issued by the Delegate of the Registered Organisations Commissioner on 30 January 2019 [[2019] ROCD 9] is corrected as follows:

and inserting: Goulburn (3)

[2] On 20 November 2018 the New South Wales Teachers Federation (NSWTF) Branch of the Australian Education Union (the Branch) lodged prescribed information for an election to fill offices. On 29 November 2018, the Branch lodged amended prescribed information in relation to the election. On 15 January and 24 January 2019 the Branch lodged further amended prescribed information in relation to the election.

[3] In particular, on 24 January 2019, the Branch lodged amended prescribed information on two occasions, the first at 2.54pm and the second at 4.38pm. The second notification referred to, and amended, a single figure contained in the previous 2.54pm lodgement. This amendment was to increase from two to three the Additional Branch Conference Delegates due for election for the Goulburn Association. The original decision was based upon the prescribed information lodged at 2.54pm on 24 January 2019 which lead to an error in my decision concerning the number of offices required for the Goulburn Association. This decision corrects that error.

[2] The above offices relate to a scheduled election for the Branch. I note a number of inconsistencies and ambiguities in the expression and operation of the relevant Branch Rules (the rules) with respect to the election of additional Branch Conference delegates. These are outlined below.

[3] Rule 7 deals with the composition of Branch Conference. Rule 7(1)(c) provides that:

There shall be a Branch Conference which shall consist of...additional representatives elected **by and from members of association**...[my emphasis]

[4] Rule 7(2) provides that:

For the purposes of this rule, the entitlement of an association to additional representatives is calculated by subtracting the number of **Branch Council representatives of associations** [my emphasis] from the figure determined by applying the following formula:

- (a) In respect of the first 80 financial members of **an association** [my emphasis] or part thereof, one representative; and
- (b) In respect of every 120 financial members or part thereof in excess of 80 financial members, one representative.
- [5] Rule 11 deals with the composition of Branch Council. Rule 11(1) provides that:

There shall be a Branch Council which shall consist of:

.

(b) Representatives elected by and from members of **associations or groups of associations** [my emphasis];

[6] Rule 11(2)(a) provides:

For the purposes of sub-rule 1 where the financial membership of an association, or a group of associations, exceeds 90 but does not exceed 250, **the association or group of associations** [my emphasis] shall be entitled to one representative and, for each additional 250 members or part thereof, one additional representative.

[7] Rule 37 deals with the election of Additional Representatives to Branch Conference. Rule 37(1)(a) provides that:

Additional Representatives [shall be] elected by and from members of associations or **groups** of associations [my emphasis].

[8] I note from the ROC's records that the interpretation of Branch Council 'representative' for the purpose of calculating the numbers of office positions available has, in previous elections, been a point of discussion between the Branch and the Fair Work Commission, the ROC's predecessor. In those discussions, the Branch's interpretation of Branch Council representatives was based, and continues to be based, on the financial membership of each association in accordance with the formula set out in Rule 11(2)(a) whereas the Fair Work Commission interpretation was based on whether the office positions were occupied or vacant at the time that the election was to be held. In my view, both interpretations are arguable because the rule lacks sufficient clarity. Having regard to the difficulty in applying Rule 7(2) it is recommended that the Branch consider amending the rule to clarify the meaning of Branch Council' representative' because this would overcome the ongoing discussion that arises with each election as to the correct application of the formula set out in Rule 7(2).

Description of the electorate for Additional Representatives to Branch Conference

[9] My emphases set out in the rules above highlight that the respective rules describe different forms of representation derived from different electorates, to determine an association's entitlement to additional Branch Conference representatives.

Determination of association entitlement to Additional Branch Conference Representatives

[10] I note that it can be the situation that for associations to qualify for Branch Council representation they must form groups of associations in order to meet the minimum financial membership requirements according to the formula set out in rule 11(2)(a).

[11] In the case of associations which have formed groups for this purpose, it is difficult to determine an individual association's entitlement to Branch Council representation because the right to representation is derived from the combined financial membership. Nevertheless, the formula set out in rule 7(2) requires this in order to determine the association's entitlement to additional Branch Conference delegates.

[12] I note that the Branch's approach is to allocate where necessary to each association within a group, an entitlement to an additional Branch Conference representative to ensure that no individual association is disenfranchised. This approach would not appear to be in accordance with the relevant election rules set out above.

[13] In my opinion, the Branch rules which describe the electorate from which additional Branch Conference representatives are elected are inconsistent, and those rules relating to the determination of an association's entitlement to Branch Conference delegates, are difficult to apply. I am supported in this view by the Branch's own approach to ensuring that no association is disenfranchised as referred to above. In view of these matters, it is strongly recommended that the Branch consider amending its rules to provide for greater consistency and clarity in their expression and operation.

[14] I am satisfied that elections are due for the Additional Branch Conference representatives in accordance with the prescribed information as listed above.

[15] In the same prescribed information the Branch lodged with the ROC as referred to in paragraph 1, is the requirement for an election to fill the following offices, due to insufficient nominations received in a previous election (**E2018/108**):
