Arrangement for conduct of election.

- [1] On 15 September 2020, a decision was issued in this matter to arrange for an election for one Councillor in the Queensland Branch of this registered organisation arising from a casual vacancy.
- [2] Subsequently, on 21 July 2021, I issued a decision in matter E2021/127 arranging for an election of Branch Councillors for a new term of office.
- [3] As a result of communications from the Australian Electoral Commission (AEC), I understand that the casual vacancy election in this matter (E2020/179) has not yet been conducted. However, the election arising from my decision in E2021/127 i.e. the scheduled election for all Councillors for a new term of office has already been commenced by the AEC and, based on the election notice published in the 'List of current Industrial Elections' on the AEC's industrial elections webpage (www.aec.gov.au/ieb), is due to be completed shortly. This will have the practical effect of making the election arising from the original decision in this matter (E2020/179) redundant.
- [4] In circumstances where the election sought in this matter (E2020/179) was for the filling of a vacancy in what is about to become the previous term of office, and this has been overtaken by the scheduled election for a new term of office, I confirm that the AEC is no longer required to conduct election E2020/179.
