
**REQUEST FOR BRANCH EXECUTIVE ELECTION:



**Statement under section 189 of Schedule 1B  
of the Workplace Relations Act 1996**

1. I am the Secretary of the ACT Branch of the Australian Education Union, an organisation registered under the Workplace Relations Act. I am the authorised officer to make requests for elections.
2. I hereby notify on behalf of the Branch Executive as the Authorised Officer that under the provisions of section 189 of Schedule 1B of the Workplace Relations Act 1996 an election be conducted for the following positions:
