## Statement under section 189 of the Fair Work [Registered Organisations] Act 2009

- 1. I am one of the two Vice Presidents [Schools Sector] of the ACT Branch of the Australian Education Union, an organisation registered under the Fair Work [Registered Organisations] Act 2009. I am an authorised officer to make requests for elections.
- 2. I hereby lodge with Fair Work Australia the prescribed information, as required under Regulation 138 of the Fair Work [Registered Organisations] Regulations 2009, for a request for elections to be conducted by the Australian Electoral Commission.
- 3. The same name of the three vacant offices required to be elected is:

  General Membership Representative for the ACT Branch Executive.
- 4. The reasons for these elections are:
  - [a] A casual vacancy was created when a previously elected General Membership representative [Ms Ingrid Bean] was subsequently elected to the office of Vice President in January 2012.
  - [b] One office was not filled at the previous election.
  - [c] A casual vacancy in one office has been created by the resignation of Ms Jo Larkin on 30 August 2012.
- 5. Dates in relation to the election process have been discussed with the Australian Electoral Commission and are as attached.
- 6. The electorate for the first two elections referred to in 4[a] and 4[b] is all members in the General Membership sector.
- 7. The voting system for the first two elections will be a direct voting system.
- 8. In accordance with Rule 27 of the ACT Federal Branch Rules, as the term of office for the vacancy created by Ms Jo Larkin's resignation expires on 30 June 2013, the electorate for the third election referred to in 4[c] is, for nominations only, all members in the General Membership sector and for voting, only members of the AEU ACT Branch Council.
- 9. The voting system for the third election may be considered to be a collegiate electoral system.
