# Statement under section 189 of the Fair Work [Registered Organisations] Act 2009

- 1. I am the Secretary of the ACT Branch of the Australian Education Union, an organisation registered under the Fair Work [Registered Organisations] Act 2009. I am an authorised Officer to make requests for elections.
- 2. I hereby lodge with Fair Work Commission the prescribed information, as required under Regulation 138 of the Fair Work [Registered Organisations] Regulations 2009, for a request for elections to be conducted by the Australian Electoral Commission.
- The names of the vacant offices required to be elected are:
  1 General Membership Representative for the ACT Branch Executive
  1 TAFE Membership Representative for the ACT Branch Executive
  1 TAFE Alternate Membership Representative for the ACT Branch Executive
- 4. The reasons for these elections are:
  - [a] The General Membership position was not filled at the previous election on 22 May 2013.
  - [b] The TAFE Membership Representative and TAFE Alternate Membership Representative were not filled at the previous election on 22 May 2013.
- 5. Dates in relation to the election process are as attached.
- 6. Nominations for the General Membership vacancy referred to in 4[a] are to be called from all members in the General Membership sector. Should an election be necessary, in accordance with Rule 27 Vacancies on Branch Executive financial members other than TAFE and Preschool members, will vote in accordance with Rule 6 Conduct of Elections and Rule 23[A][d]. Nominations for the TAFE Representative and TAFE Alternate Representative vacancies should be called from the TAFE sector. Should an election be necessary, in accordance with Rule 27 Vacancies on Branch Executive only the TAFE membership will vote in accordance with Rule 6 Conduct of Elections and Rule 23[A][e].
- 7. The term of office for all vacancies expires on 30 June 2015.
- 8. The voting system for both elections may be considered to be a collegiate electoral system.
