Arrangement for conduct of election.

[1] On 4 February 2021 the ACT Branch of the Australian Education Union (**Branch**) lodged with the Registered Organisations Commission (**Commission**) prescribed information for an election to fill the following offices:

[2] The prescribed information indicated that the electorate for each of these offices was "... current financial member of the ACT Branch". Commission staff clarified this with the Branch on 23 March 2021 and the Branch provided email confirmation to the Commission the same day.
