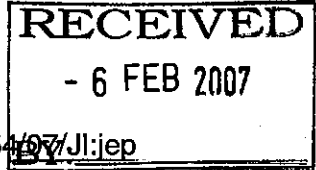

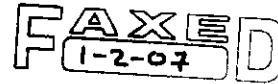

The voting system to be used in the conduct of the election is direct member election.


