To fill the above vacancies on the NSW Branch Executive. The term of office expires in March 2016 or the term of office may end in February 2015 as per Rule 6 (2A), depending upon the harmonisation and synchronisation with the NSW Teachers Federation.

#### 3. The electorate comprises:

The members of the Australian Education Union NSW Branch Council.

#### 4. The dates and times for the opening and closing of nominations are:

In accordance with direction provided by the Australian Electoral Commission under Rule 9, Sub Section (2): "Nominations for election as a member of Branch Executive shall be called by notification to all members of the Branch Council at least seven days prior to the date on which nominations close."

#### 5. Roll of voters shall close:

In accordance with Rule 9 Sub Section (3) the roll of voters shall close on the day the Australian Electoral Commission determines as the date the nominations will close.

#### 6. Voting system:

The voting system to be used in the conduct of the election is direct member election.

#### Rule 6. "Constitution of the Branch Executive"

6.(3) In the event of any casual or extraordinary vacancy occurring in an office of Branch Officer, Branch Executive may appoint another financial member attached to the Branch to fill the vacancy and the member so appointed shall hold office for the unexpired portion of the term of the office of the Branch Officer he or she is appointed to replace.

6.(4) In the event of a casual or extraordinary vacancy occurring in an office of Executive Member the Branch Executive may appoint another financial member to fill the vacancy and the Branch Councillor so appointed shall hold office for the unexpired term of the office of the Executive Member he/she was appointed to replace.

Rules 6.(3) and 6.(4) above that deal with casual or extraordinary vacancies give the power to appoint a replacement to the Branch Executive for the expired portion of the term of office.

We believe that the recent changes to our Rules 6.2 and 6.2A, which were approved by the Fair Work Commission, extended the term of office to two years so that we can harmonise and scrutinise elections with the NSW Teachers Federation. We believe this is overridden by the Fair Work Act and therefore elections will need to occur.
