**Prescribed Information: Section 189(1) of the Fair Work

In accordance with Section 189 (1) of the Fair Work (Registered Organisations) Act 2009 and Regulation 138, I wish to lodge the following prescribed information for an election required in the NSWTF Branch of the Australian Education Union for the under mentioned office.

**Name of Office:**

One Federal Executive Member representing the General Division of the NSWTF Branch.

**Term of Office:**

The person elected shall hold office until 29 February 2016.

**Reason for the Election:**

This election is required following the appointment by Federal Executive of Maurie Mulheron to the casual vacancy of Deputy Federal President in accordance with Federal Rule 37(3)(a) (d) & (e), thereby creating a casual vacancy in the above position.

**Electorate:**

The electorate is members of the NSW Branch Council who are assigned to the General Division (Rules 35(1)(d) & 35(6)).

**Date and Times:**

Federal Rule 35 (6) (b) specifies that the processes for the conduct of the election should as far as is practicable be the same mode of election as prescribed in the relevant Federal Branch Rules.

Opening and Closing of Nominations:

Nominations open at least seven days prior to the date on which nominations close and at least 30 days before the date fixed for the election. The returning officer shall determine the date on which nominations close and the date of the ballot if required.

Voting System:

The voting system to be employed in the conduct of the election for the office is a collegiate voting system.
