## Organisation must respond to the post-election report of the Australian Electoral Commission: E2015/265

On 10 May 2016 the Fair Work Commission (the Commission) received a post election report from the Australian Electoral Commission (AEC) for election E2015/265 dated 6 May 2016. The AEC will have also provided the report to the organisation under section 197 of the Fair Work (Registered Organisations) Act 2009 (the RO Act).

The report identifies rules that were difficult to interpret or apply, in particular rule 109 of the Northern Territory Branch rules. I understand that that Branch is in the process of altering its rules to remedy the problem. This letter serves as a reminder of other obligations imposed on the organisation or branch as a consequence of the AEC's report. If a response has already been sent to the AEC and made available to all members please disregard this letter.

#### A written response must be provided to the AEC

Section 198 of the RO Act requires that a written response is provided to the AEC within 30 days of receipt of the report. The organisation's response must include whether the organisation or branch intends to take action and if so what action the organisation or branch intends to take (s198(2)).

#### A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regs 141(4) and (5)).

#### Extract of report and written response must be made available to members

The organisation or branch must make the section of the report relating to the difficult rules available to its members (s198(3)). This extract from the report must be made available to the members before or at the same time as the organisation's response is made available to members.

A copy of the organisation's response must be made available to members either:

- within 30 days after the response is given to the AEC, or
- published in the next edition of the organisation or branch journal (s198(5))

Subsection 198(6) and regulation 142 prescribe ways in which the relevant extract and the copy of the response can be made available to members. These do not limit the ways in which they can be made available to members. The organisation will comply if it does all of the following:-

 publish the report extract and the copy of the response in the next edition of the organisation or branch's journal; and

- within 30 days of giving the response to the AEC:
  - lodges with the Commission a copy of the relevant extract and response, together with a declaration that a copy will be provided to any member who so requests; and
  - give notice in the next edition of the organisation or branch's journal, or an appropriate newspaper, that a copy of the relevant extract and response are available on request to each member free of charge; and
- publish the relevant extract on the website within 14 days after receiving the report, and publish the response on the website within 14 days of giving the response to the AEC (reg 142(2)).

#### Penalties may apply

If the organisation or branch does not:

- respond to the AEC within 30 days,
- make the extract of the report relating to the rules available to members no later than the organisation's response is made available to members, or
- make the organisation's response available to members within 30 days or in the next edition of the journal,

the organisation may face penalties under the RO Act. Each requirement listed above is a civil penalty provision that may result in fines for the organisation

#### Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Fair Work Commission (the Commission) a declaration of results for the election [E2015/265]. This letter is a reminder of certain obligations imposed on organisations and persons elected to office.

Section 154D(1) of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires the rules of organisations (and branches of organisations) to require each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe.

Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which should be provided for in your organisation's rules.

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission within 35 days of any changes to the holders of office in the organisation. If there are no changes a notification is not required. If the election has resulted in any changes to the holders of office, the Australian Education Union-Northern Territory Branch must notify the Commission of these changes. In particular, please advise:

- 1. Person(s) who have ceased to hold office:
  - the name of the office vacated;
  - the date of the change of office holder; and
  - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
  - the name of the office now held;
  - the date of the change of office holder;
  - the name of the person now holding the office;
  - the postal address of the person (generally the postal address of the organisation); and
  - the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. I have attached a template notification of changes which may assist you. If any change does not apply until a specific date, you don't need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

#### Re: Prescribed Information for the election of a Branch Executive Councillor

In accordance with Section 189 (1) of the *Fair Work (Registered Organisations) Act 2009* and Regulation 138, I wish to lodge the following prescribed information in relation to an election due to be held for an office in our Branch.

I am the Branch Secretary of the AEU NT Branch and am authorised to lodge this prescribed Information on behalf of the Branch.

#### Name of office and number of positions

ONE Executive Councillor representing the Darwin Region (Rule 18 (a) (vii)).

#### Reason for the election

This election is required as a result of a vacancy resulting from insufficient nominations received to fill this position in the recent AEU Branch election (E2015/187).

Attached is a copy of the AEC declaration of results for your information.

Our Branch's Casual Vacancy rule requires that this position be filled in this manner as there is not less than three quarters of the term of office remaining (Rule 27 (b)). Please note that this rule was recently changed to comply with the Act (R2015/124).

#### The electorate for the ballot

The electorate is financial members of the Branch within the Darwin Region (Rule 108 (d)).

#### The dates and times for the opening and closing of nominations

Rule 109 provides that nominations for ordinary Branch Executive positions open on 22 July and close on 21 August. I would infer from this that the nomination period be 30 days.

In determining the date for the opening of nominations, I would ask that you be mindful that the great bulk of the electorate are school teachers who will be on compulsory annual leave from 11 December until 21 January 2016. During this period, it will be difficult to communicate information by traditional means to members via their workplace representatives.

Therefore it would be preferable to either hasten to open nominations, or wait until the 2016 school year commences.

Under Rule 137 (B), Executive Councillors commence their biennial term on the third Monday in January. Our first Branch Executive meeting of 2016 is likely to take place in March.

#### The day provided for in the rules on which the roll of voters is to be closed

The roll of voters closes seven days before the opening of nominations (Rule 105 (a) (ii)).

#### The voting system to be used

The election shall be conducted by a direct voting system.
