*Arrangement for conduct of election.*

[1] On 8 April 2020, a decision was issued in this matter by a Delegate of the Commissioner to arrange for an election arising from two casual vacancies in the office of Executive Councillor – one for the Alice Springs Region, the other for the Palmerston and Rural Region – for the remainder of their terms.

[2] Subsequently, on 24 May 2021, I issued a decision in matter E2021/63 arranging for an election for Councillors representing various regions, for a new term of office.

[4] As a result of communications from the Australian Electoral Commission (AEC), I understand that the casual vacancy election in this matter (E2020/46) has not yet been conducted. It has therefore become apparent that the later election decision – because it is an election for a new term of office – will have the effect of superseding the election sought to be arranged through the original decision in this matter.

[5] In circumstances where the election sought in this matter was for the filling of vacancies in what will be the previous term of office, and the election for a new term of office (E2021/63) is currently underway, I confirm that the AEC is no longer required to conduct election E2020/46.
