Irregularities

Details of written allegations of irregularities, and action taken by AEC:

A candidate for the office of Branch President requested that the Returning Officer review election material being circulated to members by a second candidate, to determine whether this material complied with the AEU NT Branch Rules, or could result in an irregularity. The Returning Officer reviewed the material and advised that there were no actions required.

Other irregularities identified, and action taken:

As a consequence of the COVID pandemic, and the impact on mail delivery to the Northern Territory and to regional and remote locations within the Northern Territory, ballot material posted for this election was delayed in reaching voters, a significant proportion of who list their school address as their address for receiving mail from the AEU NT Branch. So as to avoid the potential for an irregularity, the ballot period was extended beyond the Northern Territory school holiday period and closed on 1 March 2021.

Other Matters

Returning Officer actions required (Section 193): Yes Details:

- 1. The original timetable for this election was modified to allow the election to be completed prior to the completion of the 2020 school year in the Northern Territory as a consequence of the COVID Pandemic and the deferral of Industrial Elections by the AEC.
- 2. Nominations were only accepted via the AEC portal or via email.
- 3. A nomination withdrawal period was included which was the date and time of the close of nominations.
- 4. The scrutiny was conducted at the AEC Victorian State Office.
