I hereby lodge prescribed information in accordance with Section 189 of Schedule 1B and RAO Schedule S189(1) of the Workplace Relations Act 1996.

#### **1. Name of Office**

An election is required for each of the following offices:

- I. General Division Delegates to Branch Council
- II. Alternate General Division Delegates to Branch Council
- III. Ordinary Branch Executive Officer (ATSI position)
- IV. Ordinary Branch Executive Officer (SSO position)

#### **2. Reason for the Elections**

Elections for the offices identified in (I) and (II) are required because the terms of office will expire on 20 March 2008.

Elections for the offices identified in (III) and (IV) are required because no nominations were received when these positions were previously called. The term of office of these positions expires on 31 December 2007.

#### **3. Number of Offices and Electorate**

The number of offices and electorate for the elections identified in (I) and (II) is attached as Annexure A.

The electorate for Ordinary Branch Executive Officer (ATSI position) is by and from financial members of the Branch, provided that the member being nominated and the nominators are Aboriginal or Torres Strait Islander members.

The electorate for Ordinary Branch Executive Officer (SSO position) is by and from financial members of the Branch assigned to the SSO Sub-division.

#### **4. Date and Times**

Federal Branch Rule 50 requires the Branch Returning Officer to determine a timeline which will enable the elections identified in (I) and (II) to be completed by 20 March 2008.

#### **5. Closer of Roll of Voters**

Federal Branch Rule 52(1A) requires the Roll of Voters to be closed seven days before the day on which nominations open.

## 6. Voting System

The voting system to be employed in the conduct of these elections is a direct voting system. The register of members is held at the Branch Office at 163 Greenhill Road, Parkside, South Australia.
