s.189—Arrangement for conduct of an election

*Arrangement for conduct of election.*

[1] On 8 July 2013 the Australian Education Union - South Australian Branch lodged with the Fair Work Commission the prescribed information in relation to an election for the following offices:

- Branch President
- Branch Secretary
- Branch Female Vice-President
- Branch Male Vice-President
- Ordinary Branch Executive Officers (12) (of whom at least six shall be women)
- Ordinary Branch Executive Officer (the SSO member)
- Ordinary Branch Executive Officer (the CS member)
- Ordinary Branch Executive Officer (the TAFE member)
- Ordinary Branch Executive Officer (Aboriginal or Torres Strait Islander member)

[2] The Branch was informed that the prescribed information was not lodged before the day prescribed by Regulation 138(3) of the *Fair Work (Registered Organisations) Regulations 2009*. That day is the day occurring 2 months before the first day when a person may, under the rules of the organisation or branch, become a candidate in the election. The Branch then asked me to allow a later day for lodgment of the prescribed information under subsection 189(2) of the *Fair Work (Registered Organisations) Act 2009* (the Act). Having considered the reasons for late lodgment, I allow lodgment on 8 July 2013 in this instance

[3] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

- 3.2. The electorate for the offices of 12 Executive Officers (including at least six women) is by and from financial members of the General Division of the Branch, other than members assigned to the Children's Services and School Services Officer Sub-divisions.
- 3.3. The electorate for the office of Schools Services Officer member of Branch Executive is by and from financial members of the School Services Officer Sub-division of the Branch.
- 3.4. The electorate for the office of Children's Services member of Branch Executive is by and from financial members of the Children's Services Sub-division of the Branch.
- 3.5. The electorate for the office of TAFE member of Branch Executive is by and from financial members of the TAFE Division of the Branch.
- 3.6. The electorate for the office of Aboriginal or Torres Strait Islander member of Branch Executive is all financial members of the Branch, provided that the member being nominated and the nominators must be Aboriginal or Torres Strait Islander members of the Branch.

**4. Date and Time**

The date for the opening of nominations shall be not later than 23 August 2013 and nominations shall close at 12.00 noon on 6 September 2013.

**5. Roll of Voters**

The date for the closure of the Roll of Voters shall be seven days before the day on which nominations open.

**6. Voting System**

The voting system to be employed in the conduct of these elections is a direct voting system.
