1(2)(a) Members who are in the General Division shall be allocated to one of three Sectors...

The union relies on members reporting to them when they change, Sectors, Workplaces, Regions etc so the membership records may not reflect a complete record of the member's attachment to a Sector etc. It may have also been unclear to members which Sectors, Regions etc they were assigned – as some Members did nominate for positions for which they had no entitlement. This further complicated and delayed the acceptance of nominations process and the ballot paper draw had to be delayed.

32(10) A candidate for election must be financial at the time of nomination...

The date and time of joining, as well as the date of nominating become crucial in determining eligibility to nominate, and resulted in new members nominations being accepted, despite them not being eligible to vote as they were not members at roll close.

Following discussions with the Australian Electoral Commission, it has been brought to our attention that some of our membership figures appeared inaccurate.

Upon further examination, it became apparent that there had been 'double counting'. This occurred as follows:

- Support staff were included in the Secondary College Sector members. They should only be in Support Staff Sector.
- TAFE Support Staff were included in Support Staff Sector (and TAFE Division). They should only be in TAFE Division.
- DoE Sector Members included Support Staff. Support Staff should only have been included in Support Staff Sector.

Arising from this inaccuracy, there is no change to the actual positions available for election, only the numbers have been reduced in the following areas:


