I, Helen Richardson, being the President of the Australian Education Union Tasmanian Branch make the following further amended statement:

1. I am authorised to sign this statement containing prescribed information the Australian Education Union Tasmanian Branch.
2. The following information is lodged under subsection 189(1) of the Fair Work (Registered Organisations) Act 2009 (the RO Act).
3. The elections that are required are set out in the table in Annexure A.
4. No rule alterations are pending that will impact the election.
5. This statement is lodged at least 2 months before nominations open for the election(s) in Annexure A.
6. Where the number of elected representatives is calculated on a formula provide the following information:
  - a. The rule numbers which specify the formulas are noted below in relation to the relevant roles:
    - a. Branch Council Delegates TAFE Division; **and** Branch Council Delegates Secondary Colleges Sector. Rule 5(2)(a).
    - b. Branch Council Delegates DoE Sector, Southern Region, Northern Region and North West Region. Rule 5(3)(a).
    - c. Branch Council Delegates Support Staff Sector, Southern Region, Northern Region and North West Region. Rule 5(3)(b) and Rule 5(2).
    - d. TAFE Division sub-branch Council Delegates. Rule 14(1)(h).
  - b. The relevant formulas for each noted above are:
    - a. Up to the first 100 members – 3 Delegates for each 100 Members or part thereof in addition to the first 100 members up to 800 members, an

additional delegate. For each 150 members, or part thereof in addition to the first 800 members, an additional 1 delegate.

- b. In each geographic Region sub-branches will be classified as Urban or Non-Urban. Of the Delegates elected from each region, at least two Delegates must be from Urban sub-branches and at least two Delegates from Non-Urban sub-branches, so long as sufficient Delegates have been nominated from either classification or subbranch.

- (ii) The number of Delegates to be elected from each Region will coincide with the percentage of Department of Education members who work in each Region. In cases where the number of Delegates determined for a Region is not a whole number, the quotient will be rounded up to the next whole number when the fraction is 0.5 or higher.

- c. The number will coincide with the percentage of Support Staff Members who work in each region. If the number of delegates determined for a region is not a whole number the quotient shall be rounded up to the next whole number if her fraction is 0.5 or higher. Provided that in cases where this would result in the election of a greater or lesser number of delegates than Rule 5(2) allows, the quotients for each region will be adjusted as follows: Should the number of Delegates need to be increased the region with the highest fraction will be increased by one Delegate; or should the number need to be decreased the region with the lowest fraction shall be decreased by one member.

- d. Delegates elected by and from members in TAFE Division Sub-branches elected on the basis of one Delegate for each 25 members or part thereof attached to the Sub-branch in excess of 25 members. One delegate for each 25 members of part thereof attached to the sub-branch in excess of 25 members.

- c. The information for calculating the formula(s) is the number of financial members attached to the relevant sector, division and sub-branch as at COB 30 June 2020 prior to the opening of nominations. See rule 5(2).

- d. The relevant date(s) for this information is COB 30 June.

- e. The relevant information for calculating the information has not been provided because the relevant date and time is in the future
