The information is being lodged under subsection 189(1) of the Fair Work (Registered Organisations) Regulations 2009

As the term of office of **ordinary members of Branch Council** from the TAFE and Adult Provision Sector and the Early Childhood Sector expires on 31 December 2012, elections are required to determine the holders of those offices for the years 2013 to 2015, inclusive. #### 1. Roll of voters shall close:

In accordance with Rule 57 (2A), the roll of voters closes 7 days before the opening of nominations.

#### 2. Voting system: Direct Method 48(5)

Members shall be elected by a secret ballot conducted at a meeting of members elect of the relevant sector council held immediately following the conclusion of the sector council elections for the purpose of conducting the election.
