The information is being lodged under subsection 189(1) of the RAO Schedule. This information was lodged with Fair Work Australia on Feb 27 2013.

#### I seek to amend the prescribed information provided as follows;

The Offices and positions requiring amendment are as follows;

- a) 1 ordinary Member of Secondary Sector Council LCM 1. This vacancy was caused by the resignation of Euan Morton and evidence of his resignation has been previously provided. A vacancy exists in Secondary Sector LCM 1 This position was incorrectly advertised as a vacancy in LCM 2 where no vacancy
- b) 1 ordinary Member vacancy was advertised under TAFE and Adult Provision Sector as a vacancy in the AMES area. No such vacancy exists. Vacancy should be withdrawn
- c) Two vacancies were notified under TAFE and Adult Provision for Chisholm Institute of TAFE.

The first vacancy was caused by the resignation of Peter Banfield and evidence of his resignation has been previously provided. This vacancy continues to exist and I seek to advertise it.

The second vacancy was caused by the retrenchment of Billy Woltenholm from Chisholm Institute of TAFE in November 2012 at the time of the original recal of elections E2012/313. Billy Wolstenhome is no longer eligible to represent this electorate as he is no longer employed by Chisholm Institute of TAFE nor is he eligible to be a financial member of the Australian Education Union under rules;
