I, Gillian Robertson, Branch Secretary of the Australian Education Union Victorian Branch, am authorised to lodge the following prescribed information in relation to elections in the Australian Education Union Victorian Branch. The information is being lodged under subsection 189(1) of the Fair Work (Registered Organisations) Regulations 2009

As the term of office of **ordinary members of Branch Council** from the Early Childhood Sector expired on 31 December 2012, elections were required to determine the holders of those offices for the years 2013 to 2015, inclusive. The numbers to be elected are specified in ATTACHMENT 1 and have been determined under Rule 8.

As **at December 7 2012** only one of the five representatives had been elected. I seek a recall of this election to fill the unfilled four Early Childhood ordinary members of Branch Council.

#### The date and times for the opening and closing of nominations are:

The dates and times for the opening and closing of nominations **will be determined by the Returning Officer from the Australian Electoral Commission** having regard to 48(5). I would suggest the Returning Officer consider the following;

#### Early Childhood Sector;

12 <sup>th</sup> July 2013	Nominations Open
2 <sup>nd</sup> August 2013	Nominations close during the Sector Council Meeting to be held on Friday August 2,
2 <sup>nd</sup> August 2013	If a ballot is necessary it can be conducted at the Sector Council Meeting on Friday August 2.

#### 1. Roll of voters shall close:

In accordance with Rule 57 (2A), the roll of voters closes 7 days before the opening of nominations.

#### 2. Voting system: Direct Method 48(5)

Members shall be elected by a secret ballot conducted at a meeting of members elect of the relevant sector council held immediately following the conclusion of the sector council elections for the purpose of conducting the election.
