Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested offices for [E2016/251]. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Yes that would appear to be the case, however the wording of paragraph 4(2)(b) to our reading states that it is the total number of the Sector divided by 50 (iii), and then this number is subsequently apportioned to the regions, having regard to the number in the region.

I note that this was also the case regarding the Primary Sector last year, the solution to which appeared to be rounding down the number of Delegates for the Wangaratta Region from 5 Delegates to 4, despite the total membership being 231.

There appears to be some ambiguity in the interpretation of the Rules, however I believe this would be an appropriate solution in line with paragraph 4(2)(b).
