Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Fair Work Commission (the Commission) a declaration of results for the election [E2016/61] for the Victorian Branch. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the *Fair Work (Registered organisations) Regulations 2009*).

Holders of office required to undertake approved training

Section 154D(1) of the Fair Work (Registered Organisations) Act 2009 (the RO Act) requires the rules of organisations (and branches of organisations) to require each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe.

Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which should be provided for in your organisation's rules.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission **within 35 days of any changes** to the holders of office in the organisation. **If there are no changes a notification is not required.** If the election has resulted in **any changes** to the holders of office, the Australian Education Union-Victorian Branch must notify the Commission of these changes. In particular, please advise:

1. Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.

2. Person(s) who have commenced to hold office:
 - the name of the office now held;
 - the date of the change of office holder;
 - the name of the person now holding the office;
 - the postal address of the person (generally the postal address of the organisation); and
 - the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. I have attached a template notification of changes which may assist you. If any change does not apply until a specific date, you don't need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.



Post-election Report for the Australian Education Union E2016/61

I refer to your post-election report dated 1 July 2016, which we received by email on 9 July 2016.

I note that you identify rule 52(6)(d) of the Rules of the Victorian Branch of the AEU as a "difficult rule", though I understand that the intended reference is to rule 50(5)(d) (**Difficult Rule**), which provides:

"Nominations for the positions of ordinary members of sector councils shall ... be delivered to the Branch Returning Officer at the registered office of the Branch not later than 12.00 noon on the first Friday in September."

Pursuant to section 198(2) of the Fair Work (Registered Organisations) Rules 2009 (Cth) (**FW(RO) Act**), I wish to inform you that the Victorian Branch of the AEU has amended the Difficult Rule at its most recent Branch Conference to be held in 30 July 2016. The amendment is in the process of being filed with the Fair Work Commission. The amendment provides the following sub-rule to rule 57:

"(3A) For the avoidance of doubt (and notwithstanding anything else contained in these Rules), where in these Rules a nomination is required to be delivered to the Branch Returning Officer and the Australian Electoral Commission acts as the Branch Returning Officer, delivery shall be effected by means which include the following:

- (a) Physically delivering the document to, or an office of, the Branch Returning Officer;
- (b) Sending the document by post to, or an office of, the Branch Returning Officer;
- (c) Emailing the document to, or an office of, the Branch Returning Officer (provided that the sender retains a copy of the document to be produced on request to the Branch Returning Officer); or
- (d) Sending the document by facsimile transmission to, or an office of, the Branch Returning Officer (provided that the sender retains a copy of the document to be produced on request to the Branch Returning Officer)."

The AEU will make available this response to members in accordance with section 198(3) of the FW(RO) Act.
