

I am an officer of the Australian Education Union (W.A. Branch) and am authorised to sign this statement which is lodged in accordance with subsection 189 of the RAO Schedule [Schedule 1B, to the Workplace Relations Act 1996].

In accordance with the requirements of the Rules of the Australian Education Union (Western Australian Branch), specifically Rules 6(1)(a) and (b), I request the Australian Industrial Relations Commission to instruct the Australian Electoral Commission to hold an election for positions which will become vacant pursuant to the constitution of the A.E.U.W.A.

This is the first tier of a two-tier election system and will require an election under Rule 2 (1) for the following offices:
