

No specific dates are prescribed for the conduct of the elections. The rules reference below refer to the time periods required for the functions of calling for nominations, and the time period between the opening and closing of the ballot, if required.

RULE No[s] 24(3); 24(4); 24(20).

The elected officers do not commence their positions until 1 January 2011. We would like to plan for the election results to be declared by 31 December 2010.

#### Closure of the Roll of Voters:

The day on which the roll of voters is to be closed is 30 days before the day on which nominations open - Rule 24(11)(b)(ii).

#### Elected by:

The electoral system employed is a direct voting system.

#### The rules require the result of election to be decided by:

First past the post system – RULE No(s) 24(30a, b, c, d); 24(34).
