We refer to your correspondence of 18 July 2008, regarding the election of pilot councils covering Jetstar and Virgin Blue pilots.

The Federation at its Annual 2007 Convention held in September passed two separate resolutions:-

BE IT RESOLVED that this Convention endorses the formation of a Virgin Blue Council, subject to ballot and majority support of the voting Virgin Blue AFAP members.

For 15
Against 2
Abstentions 1

BE IT RESOLVED that this Convention endorses the formation of a Jetstar Council and delegates the authority to Executive Committee as to when and how this Council will be activated.

Carried
For 14
Against 3
Abstentions 1

On the second day on which the above resolutions were carried 18 Convention representatives attended. This represented in excess of a quorum. The maximum number of delegates determined by pilot numbers in each Branch and Council at that time was 21. A simple majority was achieved. There were four proxies on that day one each from WA, Queensland, NSW and Victoria.

Pilot Councils have been the subject of discussion for a number of years at both Executive and Convention Meetings and Councils were an agenda item again in 2007.

In relation to Councils the Federation's Rule 7 sub section 2 (e) specifies:

The Convention shall have the power from time to time to establish or dissolve a Council.

In relation to the Virgin Blue Council the election was held last month with a 92% vote in favour of the establishment of the Council. The ballot opened on 6 June and closed on 24 June. 91 votes were received. The notification of the ballot and result is attached.

At the Executive Committee held on 9/10 July 2008 the matters were dealt with again and the following extracts of relevant minutes and resolutions passed are reported in relation to the Councils:-

Virgin Blue Pilot Council

Mr O'Connell advised Executive that the ballot of Virgin Blue members concerning the formation of a Virgin Blue Pilot Council had been held last month. It was reported that 79 pilots had voted in favour and 7 against. It was also noted that 5 pilots voted twice and these duplicate votes were not counted.

Jetstar Council

Mr Cox updated Executive Committee on the status of the Jetstar Committee following the resolution from the February Executive, which approved the formation of a Jetstar Pilot Council and elections for the committee coinciding with normal branch elections. He advised that the intention was to create an interim committee until a Council was formalised through the election process.

WHEREAS the 2007 Convention authorised the creation of the Jetstar Pilot Council under the rules of the organisation.

WHEREAS the elections for State Branch Committees and Council Committees are now due and it would assist by having an interim committee.

BE IT RESOLVED that the Executive forms the Jetstar Council on an interim basis until the normal election cycle occurs.

BE IT FURTHER RESOLVED the interim committee be made up of Captain Lester Lewis as Chairman, Captain Nathan Miller and Captain Mark Smith.

CARRIED

The Councils are not the subject of Appeal and no disputes have been referred to Convention.

Turning to questions you have raised:-

• Is the Federation of the view that membership of a branch and a council is mutually exclusive?

Yes, in accordance with Rule 4 sub section 1 (c) and Rule 4 sub section1 (h) (ii):

• If so, is the Federation of the view that some current Branch Committee members and/or Officers will be removed from office because they are no longer eligible to hold office under the Rules?

Our rules do not appear to cover transitioning from one branch to a Council. It may be that a Branch member has the choice to stay on until the term is completed if that committee member/ office holder so desires. Once the election is called the affected persons will be notified and it is expected most if not all will resign and move to the Council.

• If that is the case, the Registry will require either copies of letters of resignation from the relevant office holders or, for those office holders who have not resigned, information about what action the Federation has taken, or is taking, to remove such persons from office under the Rules.

See above.

A copy of the Agenda for the 2007 Convention is attached. The 2007 Convention minutes are draft and will be processed at this year's Convention. The Executive Committee Minutes of July 2008 are draft and will be processed at the next Executive. I have copied relevant sections.

The Federation's Rules require Elections to be called for on or about August 15 of each year. This Rule has existed for many years and has been used flexibly over the years with Registry acquiescence. We acknowledge Mr Ophel's correspondence of 2007 and will take steps to address some of the issues raised therein.

Captain Murray will be in the office tomorrow after working for the past three days and will initiate the necessary paperwork required for the Section 189 notice.

In a newsletter last year I advised that the Federation's Annual Convention passed a resolution to establish a Pilot Council for the Virgin Blue Pilot group subject to your support,

Councils exist under the Federation's rules to enable a group of pilots of one employer "...to be responsible for all matters affecting employment conditions of members of the Council". In other words if the Virgin pilot group supports the resolution it means that Virgin Blue pilots will for the first time have a direct vote at the Federation's Executive Committee and Convention based upon membership numbers.

You will have *your* Council focussing on *your* issues through *your* elected VB pilot peers with direct representation at Executive Committee and Convention meetings.

Please note that the formation of a Pilot Gouncil will not affect the workings or composition of the Pilot Workplace Committee (PWC). This is a committee established by your Adreement of deal with certain workplace matters.
