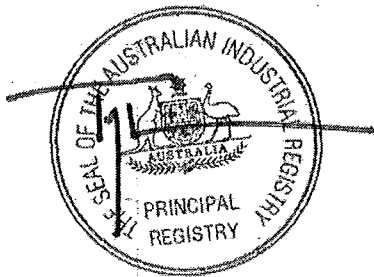

[3] Note regarding new Jetstar Council and new Virgin Blue Pilot Council

The previous election for the organisation (E2008/225) included offices in a new Jetstar Council and a new Virgin Blue Pilot Council which the organisation has advised were established in 2008 – see AFAP correspondence to the Australian Industrial Registry dated 23 July 2008. The present election also includes offices in these new Councils. I therefore draw attention to the following comments that were included in my decision in respect to E2008/225:

I note the view expressed by the organisation in its letter dated 23 July 2008 that membership of a Branch and a Council is mutually exclusive in accordance with Rule 4 subrule 1(c) and Rule 4 subrule 1(h)(ii). I also note the provisions of Rule 4 subrule 4(a)(ii) that the position of a member of a Branch/Council Committee shall be vacated if the member of the Committee ceases to be a member of the Branch/Council. I hold no view regarding whether the organisation has complied with its obligations regarding the loss of office by any incumbent office-holder due to the establishment of the Jetstar Council or Virgin Blue Pilot Council.

[4] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of Schedule 1 of the Workplace Relations Act 1996, I am making arrangements for the conduct of the election by the Australian Electoral Commission.




