# Notification of changes – Action required

Dear Stephen Ferguson,

We acknowledge receipt of a Notification of Change to the office holders of the Australian Hotels Association (AR2020/50).

A list of those changes has been summarised in Appendix A at the end of this letter.

I note that no branch was provided on the notification regarding New South Wales office holders, only in the accompanying email. Please include this information in any notification lodged in the future.

#### What you need to do right now

- Any person who has been elected or appointed to a new office that has financial management duties (which usually includes all the committee of management)
  MUST do <u>financial training</u> or <u>obtain an exemption</u>
- Inform all officers of their <u>disclosure obligations</u>
- Consider giving your new officers the link to the ROC's Officer Induction Kit

These next steps are explained below in more detail.

#### Late notification warning

Appendix A contains late notifications. Please inform the relevant officer that this has been recorded against AR2020/50.



Late notifications are a serious issue that impacts on the transparency of the whole organisation to its members. Members should be able to tell who their officers are.

We have included some resources below to help support your good governance in relation to notifications of change.

# Financial training must be done within 6 months

Any officer who has been elected or appointed to a new office that has financial management duties must complete <u>financial training</u> (or obtain an exemption) **within 6 months** after taking office (s.293K of the Fair Work (Registered Organisations) Act 2009 (RO Act)).

The organisation is responsible for this requirement. You should arrange for the relevant officers to have training as soon as possible.

Good governance processes around financial training are highly recommended. These include:

- keeping a list of all offices that have financial management duties
- having a single person or officer responsible for overseeing the process
- collecting records of who has done training or obtained an exemption, including any certificates and exemption letters
- doing refresher courses for officers who have been re-elected to the same office (and are not required to do training under the RO Act)
- extending training to non-officers who are essential to your financial processes

#### Officer financial training audit

An audit by the ROC into officer training found that organisations frequently misunderstood **which** officers are required to do training.



To help with this we have an <u>officer training online panel</u> with examples explaining what triggers the need to do training and how to identify the offices that require it.

# Help for new officers: Officer Induction Kit

The ROC has created an <u>Officer Induction Kit</u> to assist new officers. The Kit has resources that will help an officer to understand their general duties as an officer and their specific duties as an officer in your organisation. It also includes tools to guide an officer's understanding of compliance dates, disclosures and other reporting obligations.

#### Disclosure obligations: what officers must do

All officers are required to make disclosures regarding remuneration, non-cash benefits and material personal interests. Details are contained in the RO Act and are summarised in the ROC's <u>Disclosures Fact Sheet</u>.

The organisation and officers are both responsible for meeting this obligation.

# Time frames for notifications of change

Notifications of change must be lodged within 35 days of the change occurring (r 151 Fair Work (Registered Organisations) Regulations 2009).

### Resources to help you make your notifications of change

Notifications of change are vitally important to maintain the transparency of an organisation to its members. They empower members to hold the organisation properly to account for its decisions.

To ensure that organisations get these notifications right we have created resources to help you understand the notification of change requirement and complete it quickly.

These resources include:

- notification of change template
- a podcast that answers the question who is an officer?
- and a fact sheet on notifications of change that explains the requirement

#### **Advanced review**

Your Annual Return had an **advanced review** which is a comprehensive review that evaluates compliance with the requirements of the RO Act. (Under the risk-based approach adopted by the Registered Organisations Commission (ROC), all organisations will periodically receive an advanced review).

During the assessment of the AHA's 2020 annual return some discrepancies were identified between the list of office holders in the 2019 annual return and the list of office holders in the 2020 annual return, for which no notifications of these changes (or the dates on which they occurred) were found. These discrepancies are outlined below.

#### Queensland Branch

• William Cordwell was listed as State Board Delegate (Southern Zone) in the 2020 annual return but not in the 2019 annual return. No notification of change was found regarding his commencement in this office.

I note that William Cordwell was listed in a notification of change that was lodged with the ROC, as having commenced in the office of 'Central Division Zone General Committee Representative' on 5 March 2020, but he is not listed under that office in the 2020 annual return lodged on 31 March 2020. This suggests either a possible error in the title of office in the notification of change or the annual return, or non-notification.

#### South Australian Branch

 Michael Lunniss is listed as a Branch Committee of Management member for District 9 'Hills' in the 2019 annual return, but is not listed at all in the 2020 annual return, And there was apparently no notification of change submitted to the ROC in relation to Mr Lunniss.

The ROC has identified a notification of change dated 16 May 2019 which shows the office of Committee of Management (District 9: Hills) going from 'vacant' to being filled by Karen Milesi, with effect from 14 May 2019, however no indication of having been notified of Mr Lunniss having vacated office.

(SA Branch rule 17(b)(i) seems to suggest that it may be the same office, as there is only one Council member elected from District 9).

#### Victorian Branch

• Bernie Taylor is listed as a Branch Councillor from Mornington Peninsula in the 2019 annual return but is not listed at all in the 2020 annual return. No notification of change was found regarding him vacating that office.

As previously advised, the ROC is monitoring your organisation's compliance with the obligation to notify changes to office holders under section 233(2) of the Fair Work (Registered Organisations) Act 2009. Similar issues with the list of office holders were raised in relation to the organisation's 2019 annual return and it is important to ensure an accurate list of office holders is maintained.

Could you please confirm the current status of the abovementioned office holders. If changes to these office holders were not notified to the ROC (including vacancies and commencement of office), please lodge a notification of change as soon as possible.

On receipt of the requested information, the ROC will file your organisation's 2020 annual return.
