Pursuant to Rule 42 (d)(ii) the number of delegates from the National accommodation Hotels Division to the National Board in never less than 17.75% of the total number of delegates that are to be elected to the National Board in any year.

Assuming Branch Presidents are excluded from the total number of delegates elected(refer Rule11 D) then the number of delegates would be 5 including President, Vice President and Secretary but if Branch Presidents are included in the total number of delegates then the number of delegates would be 6 including President, Vice President and the Secretary.

d) Date and time of the commencement and expiration of period for calling of nominations:

The Returning Officer shall call for nominations in the presence of all members at the time designated in paragraph (b).

e) The day provided in the Rules of the Organisation as the day on which the roll of voters is to close:
