Officers of the National Accommodation Hotels Division for 2012

a) Name of each office for which election is required:

- President
- Vice President
- Secretary
- Delegates to the National Board to be determined (either 2 or 3).

b) Reasons for election:

Elections for these offices are required to be conducted annually under the Rules of the organisation and the terms of office are due to expire.

It is intended that these elections will be conducted at the meeting of the Committee of the National Accommodation Hotel Division at 11am on Thursday 1 March 2012 at the offices of the Queensland Hotels Association, Level 14, 270 Adelaide Street BRISBANE.

c) The number of offices to be filled:

One for each of the offices of President, Vice-President and Secretary. and positions for the position of Delegate to the National Board to be determined (either 2 or 3) ..

Pursuant to Rule 42 (d)(ii) the number of delegates from the National accommodation Hotels Division to the National Board in never less than 17.75% of the total number of delegates that are to be elected to the National Board in any year.

Assuming Branch Presidents are excluded from the total number of delegates elected (refer Rule 11 D) then the number of delegates would be 5 including President, Vice President and Secretary but if Branch Presidents are included in the total number of delegates then the number of delegates would be 6 including President, Vice President and the Secretary.

d) Date and time of the commencement and expiration of period for calling of nominations:

The Returning Officer shall call for nominations in the presence of all members at the time designated in paragraph (b).

e) The day provided in the Rules of the Organisation as the day on which the roll of voters is to close:


