Arrangement for conduct of election.

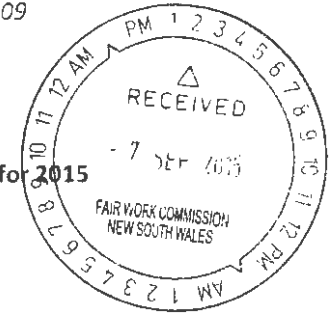

Arrangements for conduct of an election (E2015/214)

I refer to the prescribed information dated 20 July 2015 which was lodged with the Fair Work Commission on 3 August 2015 concerning an election for offices of the National Accommodation Hotels Division of the Australian Hotels Association (AHA).

The prescribed information includes a request for an election for 3 additional Delegates to the National Board of the AHA. Rule 11 of the AHA national rulebook provides information regarding the composition of the National Board based on the population of Branches, whilst rule 42(d) refers to the number of representatives from the National Accommodation Hotels Division to be elected to the National Board and which is dependent upon a percentage of the total number of delegates to be elected to the National Board.

In my view, there is some uncertainty regarding whether the number of Delegates from the National Accommodation Hotels Division to be elected to the National Board of the AHA should be three, and accordingly request that you provide amended prescribed information that provides the number of additional Delegates from the National Accommodation Hotels Division to be elected to the National Board as '(to be determined in accordance with the rules)'.

Once the amended prescribed information is lodged the Commission will be able to organise for the conduct of the election to be arranged. I think it would be prudent if the AHA at some stage in the future reviews its rulebook and makes alterations to sections which cause ambiguities.


