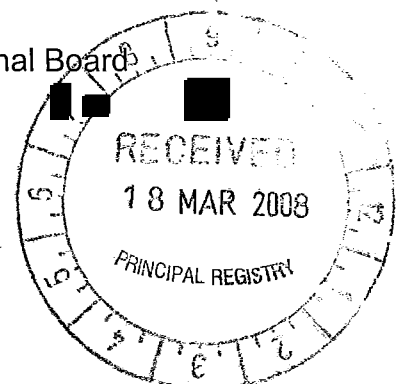
1. I am the President of the Australian Hotels Association – ACT Branch.
