We refer to the above election and the attached declaration of results. As can be seen from the attached declaration, no nominations were received by the cut-off time for close of nominations for this election.

  - No nominations received in Election E2012/222.
- (c) The number of offices to be filled:
  - Eight (8) (See Rule 11(aa)(A) (8) and Rule 11 (aa) (C) of the Rules of the Australian Hotels Association;
