Arrangement for conduct of election.

[1] On 21 February 2014 the New South Wales Branch of the Australian Hotels Association (the Branch) lodged with the Fair Work Commission (the Commission) the prescribed information in relation to a casual vacancy election.

[2] On 3 March and 4 April 2014 respectively, the Commission wrote to the Branch to request a copy of a form of documentation to evidence the reason for the occurrence of the casual vacancy.

Pursuant to rule 6 (k) of the Rules of the NSW Branch of the AHA, a casual vacancy is created and required to be filled in accordance with the Rules.


