Extension of time - Scheduled election for offices [E2015/65]

I refer to the prescribed information for a scheduled election of offices of the NSW Branch (the Branch) of the Australian Hotels Association (the AHA), which was lodged with the Fair Work Commission (the Commission) on 28 January 2015.

The prescribed information stated that the offices requiring election were two (2) Representatives to the National Accommodation Hotels Division; and eight National Board Delegates (8) - noting that one of the National Board Delegates is to be filled by the Branch President ex officio.

Regulation 138(3) of the Fair Work (Registered Organisations) Regulations 2009 provides that the prescribed day for lodgment of prescribed information for an election is the day occurring 2 months before the day when a person may, under the rules of the organisation or branch, become a candidate in an election.

As noted in the prescribed information, rule 11(e) of the National rulebook of the AHA provides that:

"(The) Returning Officer shall at least fourteen (14) days prior to the first day of April in each year call for nominations for the Branch's representatives to the National Board by circular each member of the Branch Committee of Management".

I note that the Commission wrote to the Branch on 8 December 2014 and provided a courtesy reminder about the obligation to lodge the prescribed information before the prescribed day.

The prescribed information was not lodged before the prescribed day, which in accordance with the above is 2 months and 14 days prior to 1 April 2015.

Section 189(2) of the Fair Work (Registered Organisations) Act 2009 provides that the General Manager (or her Delegate) may allow the prescribed information to be lodged on a later day.

For this purpose, could you please provide a brief letter requesting an extension of time for the lodgment of the prescribed information, and include brief reasons why it was not lodged before the prescribed day. On receipt of such a letter I will forward the matter to the Delegate of the General Manager for consideration.
