
- (a) The name of the office in respect of which an election is required is National Accommodation Hotels Division Representative.

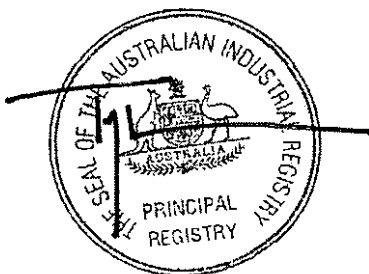
DECISION
