The prescribed information should contain details of the election as required by regulation 138(1) of the *Fair Work* (*Registered Organisations*) Regulations 2009 (the 'Regulations') and should include any subsequent elections such as an election for offices under the collegiate electoral system, if relevant. A sample of the prescribed information can be found on our website at www.fwc.gov.au/sample documents.

Section 189(2) of the Act and regulation 138(3) of the Regulations require the prescribed information to be lodged with the Fair Work Commission two (2) months before nominations open for the election. The prescribed information can be emailed to <u>orgs@fwc.gov.au</u>. Should your Branch believe that it will be unable to comply with the prescribed day as set out in the Regulations, it will need to apply to the General Manager for a later date. Such request will need to set out in detail the reason why the Branch is unable to comply with the requirement. While the General Manager will consider such an application, there is no assurance that consent to a later day will be allowed.

It should be noted Section 189(2) is a civil penalty provision. Failure to comply may result in legal proceedings being issued with the possibility of a pecuniary penalty being imposed upon an officer and/or your Branch.
