Re: Rules difficult to apply/interpret - National Rule 11 (e)

As per Section 198 of the Fair Work (Registered Organisations) Act 2009 ("the Act") I provide the following response to the post election report of the AEC relating to National Rule 11(e).

National Rule 11(e) requires that the Returning Officer (AEC) "shall at least fourteen (14) days prior to the first day of April in each year call for nominations for the Branch's representation on the National Board to circulate to each of the Branch Committee of Management".

In the case of the South Australian Branch this is not possible as the annual election of Branch Officer Bearers, i.e. President, Vice President, Deputy Vice President, Secretary/Treasurer, Executive Committee members and Trustees can only be conducted at the first Committee meeting after the Annual General Meeting ("AGM").

The South Australian Branch Rules require the AGM to be held no earlier than 1st of April and no later than 31st day of May (SA Branch Rule 14).

Tradition and practice is that the AGM is held on the day before the May Committee of Management meeting (known as the "Council"). It is at this meeting of Council that the elections for Branch Officer bearers is conducted.

It is my understanding there is no universal standard date for the AGM or Branch Council meeting across the AHA branches.

To facilitate the requirements that a National Board delegate be elected after the election of branch officers including the Branch President, the National AHA changed rule 11 (f) to reflect:

11 (f) Nominations for Elections of National Board *Paragraph 2*

"Nominations which are not completed as required by this Rule or not received at the registered office of the Branch on or before the first day of April (or such later time as allowed by the Returning Officer) shall be disregarded".

The words (or such later time as allowed by the Returning Officer) were ratified by the Fair Work Commission in their decision of 20 December 2011.

Therefore the additional wording in Rule 11 (f) gives the Returning Officer the capacity to change the date to best accommodate the SA Branch requirement to hold its AGM post 1st April but prior to 31st of May.

Please find a copy of that decision attached.

Attached also is the declaration by the National Secretary/Treasurer stating at Item 5 that the purpose of the rule change to 11(f) was "to provide the Returning Officer with discretion for extending the time for acceptance of nominations".

National Rule 11(f) has been the method that has allowed the Returning Officer to conduct elections for the Branch Delegate to the National Board post the election of Branch Office Bearers which is held after 1st April each year. This has been the case since the elections of 2012.

As a result, we believe that no further amendments are required to accommodate the election of the National Board delegate and that National Rule 11 (f) means that it is not necessary for the Returning Officer to exercise powers under Section 193(b) to remedy a procedural defect as Rule 11 (f) has effectively remedied any difficulty.

Organisation must respond to the post-election report of the Australian Electoral Commission: E2018/229

On 17/06/2019 the Registered Organisations Commission (the ROC) received a post election report from the Australian Electoral Commission (AEC) for election E2018/229. The AEC will have also provided the report to the organisation under section 197 of the Fair Work (Registered Organisations) Act 2009 (the RO Act).

The report identifies rules that were difficult to interpret or apply, in particular National Rule 11(e). This letter serves as a reminder of the obligations imposed on the organisation or branch as a consequence of the AEC's report. If a response has already been sent to the AEC and made available to all members please disregard this letter.

A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regs 141(4) and (5)).

A written response must be provided to the AEC

A written response must be provided to the AEC within 30 days of receipt of the report. The organisation's response must include whether the organisation or branch intends to take action and if so what action the organisation or branch intends to take (\$198(2)).

Extract of report must be made available to members

The organisation or branch must make the section of the report relating to the difficult rules available to its members (s198(3)). This extract from the report must be made available to the members before or at the same time as the organisation's response is made available to members.

Written response must be made available to members

A copy of the organisation's response to the AEC must be made available to members either:

- within 30 days after the response is given to the AEC, or
- published in the next edition of the organisation or branch journal (s198(5))

Subsection 198(6) and regulation 142 prescribe ways in which the relevant extract and the copy of the response can be made available to members. These do not limit the ways in which they can be made available to members. The organisation will comply if it does all of the following:-

- publish the report extract and the copy of the response in the next edition of the organisation or branch's journal; and
- within 30 days of giving the response to the AEC:
 - lodges with the ROC a copy of the relevant extract and response, together with a declaration that a copy will be provided to any member who so requests; and
 - give notice in the next edition of the organisation or branch's journal, or an appropriate newspaper, that a copy of the relevant extract and response are available on request to each member free of charge; and
- publish the relevant extract on the website within 14 days after receiving the report, and publish the response on the website within 14 days of giving the response to the AEC (reg 142(2)).

Penalties may apply

If the organisation or branch does not:

- respond to the AEC within 30 days,
- make the extract of the report relating to the rules available to members no later than the organisation's response is made available to members, or
- make the organisation's response available to members within 30 days or in the next edition of the journal,

the organisation may face penalties under the RO Act. Each requirement listed above is a civil penalty provision that may result in fines for the organisation

As noted above, if the response and report have already been made available to members and the AEC, please disregard this letter. If you have any questions in relation to these obligations please contact the ROC for assistance by email to regorgs@roc.gov.au.

If the organisation or branch decides to alter its rules in response to the AEC's report

If the organisation or branch decides to alter its rules in response to the AEC's report, the ROC is NOT able to provide advice and assistance regarding draft alterations or the processes required to make the alterations. Rule alterations remain a function of the Fair Work Commission.

Dear General Manager,

Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of contested and uncontested offices in matter E2018/229. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must, as soon as practicable after receiving the post-election report, publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the Fair Work (Registered Organisations) Act 2009 (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission within 35 days of any changes to the holders of office in the organisation. If there are no changes a notification is not required. If the election has resulted in any changes to the holders of office, the Australian Hotels Association-South Australian Branch must notify the Commission of these changes. In particular, please advise:


- 1. Person(s) who have ceased to hold office:
 - the name of the office vacated:
 - the date of the change of office holder; and
 - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
 - the name of the office now held;
 - the date of the change of office holder;

- the name of the person now holding the office;
- the postal address of the person (generally the postal address of the organisation); and
- the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

- Stage 2 of the current Scheduled Election, pursuant to AHA South Australian Branch Rule 22(b) elected the positions of President, Vice-President, Deputy Vice-President, Secretary-Treasurer, Executive Members and Branch Trustees to the Executive Committee. These positions as stated herein collectively make up the Branch Committee of Management. The election for Stage 2 was conducted at the Branch Council Meeting scheduled as an attendance ballot on Tuesday 14 May 2019 in accordance with the Organisation's Rules. 
