AMENDING DECISION

[1] On 16 September 2005, I decided that an election was required to be held for, among other offices, Branch Representative to the National Board (1) representing the Tasmanian Branch of the abovenamed organisation.

[2] Alterations to the rules of the Australian Hotels Association certified on 28 September 2005 no longer require, as a consequence, an election for Branch Representative to the National Board representing the Tasmanian Branch.

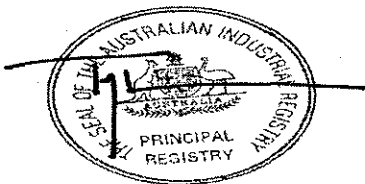

Following on from our discussion earlier this week, I am writing to advise the Registry of the number of members of this association by sub-branch and the arrangements for the position of Branch Secretary.

Members by Sub-Branch

In my letter of 29 August I had advised that the AHA Tasmanian Branch had 203 financial members at 31 December 2004. After reviewing the sub-branch membership lists it has become clear that the actual membership number for the Branch was 199. The difference was due to a small number of members being double counted.

The split-up of members by sub-branch is as follows:

- South – 96 members = 5 delegates
- North – 68 members = 3 delegates
- North-West – 35 members = 2 delegates
- **Total – 199 members = 10 delegates (plus one accommodation representative)**

Arrangements for the Position of Branch Secretary

You advised that the position of Branch Secretary is also due for re-election this year. This position has, by convention, been filled formally by the Treasurer but in practice by the General Manager.


The association is also in the process of drafting proposed rules changes (to tidy up anomalies and to add a Restaurant division).

Given this situation, it may be appropriate to not hold elections for the position of Branch Secretary this year and continue as per established conventions. By the

elections in 2006, this situation is hoped to be rectified through the planned rules changes.


