I have received your statutory declaration declared on 4 March 2002, with attachment, providing information in accordance with subsection 268(3) of the *Workplace Relations Act 1996* (the Act). The document, with attachment, was lodged in the Industrial Registry on 11 March 2002.

I refer to information contained in the statutory declaration in relation to elections. I note that elections for members to the National Board are to be conducted on Tuesday 1 April 2003. This is within the current reporting period on elections which is 1 April 2003 to 31 March 2004. Councillor elections which are to be conducted mid September 2004 and office bearers elections to be conducted mid November 2004 are within next year's reporting period. I would be pleased if you would advise the Registry of these elections in next year's annual return, as at 1 January 2004.

I should point out that the statutory declaration should have been signed by an officer of the branch. I appreciate this office has accepted statutory declarations signed by you in the past, however subsections 268(3)(a) and (b) of the Act require the lodgement of a statutory declaration by the Secretary or other prescribed officer. "Office" is defined under section 4 of the Act as an office of a voting member of a collective body of the organisation or branch, being a collective body that has power in relation to certain functions described in section 4. It would appear from the rules that the duties of 'Chief Executive Officer' are such that would not bring the position into line with the definition of "office" appearing in the Act.

I therefore request a fresh statutory declaration declared by an officer of the branch.






