Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested offices in matter E2020/13. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must, as soon as practicable after receiving the post-election report, publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission within **35 days of any changes** to the holders of office in the organisation. **If there are no changes a notification is not required.** If the election has resulted in **any changes** to the holders of office, the Australian Hotels Association - Western Australia Branch must notify the Commission of these changes. - the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

AMENDING DECISION

Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Arrangement for conduct of election

[1] On 17 January 2020, I issued a decision arranging for the conduct of an election, by the Australian Electoral Commission (AEC), for various offices in the Australian Hotels Association Western Australia Branch pursuant to section 189 of the Fair Work (Registered Organisations) Act 2009 (**RO Act**).

[2] Among those offices were the Presidents of 'Non-Territorial Divisions' in the Branch.

[3] The Branch rules, in particular rule 10B, prescribe that the Branch has two specified non-territorial Divisions: the Licensed Restaurants Division and the Accommodation Hotels Division. The Presidents of those two Divisions are also ex officio members of the Branch Executive by virtue of Branch rule 13(a).

[4] The Branch rules also provide that the Branch may create other territorial and non-territorial divisions.

[5] On 20 January 2020, following the issuing of the election decision, the Commission received correspondence from the Branch stating that in 2016 the Branch had established a 'Restaurant Division' which, the Branch advised, is separate and distinct from the Licensed Restaurants Division. The Branch also stated that there are no members of the Licensed Restaurants Division but that the separately created Restaurant Division has members.

[6] Following receipt of the Branch's correspondence, the Commission sought clarification, from the Branch and from the organisation's national office, in circumstances where the eligibility rules for membership of the Branch (set out in rule 5) are:

Any person, partnership or corporation who employs or usually employs labour shall be eligible for membership of the association provided that the labour is employed in establishments in respect of which any of the following licences have been granted:

•••

In the state of Western Australia any licence issued under the Liquor Licensing Act, 1988.

[7] In such circumstances, it is apparent that a member of the Branch must hold a relevant licence under the Liquor Licensing Act.

[8] It is a matter for the Branch what territorial and non-territorial divisions it chooses to create. However, its rules currently mandate at least an Accommodation Hotels Division and a Licensed Restaurants Division.

[9] As would be apparent, the existence of both a Restaurant Division and a Licensed Restaurants Division, particularly in circumstances where members of the organisation are required to hold a liquor licence, is likely to give rise to confusion.

[10] The rules of an organisation and its branches, and the structure adopted, are of course matters for the organisation and its branches, subject to compliance with the RO Act. However, I invite the Branch to take steps to amend its rules in order to address the confusion that arises from the current structure. I also note that it is open to the AEC to make a report on election-related rules and their application as part of its post-election report if the AEC considers it appropriate to do so.

[11] Having considered the above matters, I am satisfied that an election is required for the office of:

President, Restaurant Division

and that, in light of the advice from the Branch, the references to 'Licensed Restaurants Division' in my decision of 17 January 2020 should be deleted.

[12] I am satisfied that an election for the abovenamed office is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
