I refer to the above election for your organisation.

Section 197(1) of Schedule 1 of the Fair Work (Registered Organisations) Act 2009 requires the AEC to provide a written report on the conduct of the election to the Delegate of the General Manager, Fair Work Australia and to the organisation or branch for whom the election was conducted. A copy of the report in relation to this election is attached.

Further, Regulation 141(4) of the Fair Work (Registered Organisations) Act 2009 requires an organisation or branch to publish a notice on its web site advising members that a copy of the post election report is available upon request. If a website is not available, publishing a notice in a journal or newsletter would be considered appropriate.

I am the appointed Federal Secretary, and an elected Federal Vice-President, of the Australian Institute of Marine and Power Engineers,

I am authorised to lodge the following prescribed information concerning the forthcoming election of the Federal Executive of the Australian Institute of Marine and Power Engineers, and

I confirm that the following information is being lodged under subsection 189(1) of the RAO Schedule.

REASON FOR ELECTION:

The reason for the election being that the term of office of the Federal Executive will expire on the next meeting of the Federal Council [to be held on Tuesday 1st June 2010] and the Rules require the election to be held at this time.

ELECTED BY:

The electorate for the COLLEGIATE voting system are the seventeen (17) Federal Councillors.

NOMINATIONS OPEN:

At Federal Council - the Federal Executive election is the first item on the agenda of the annual meeting of Federal Council.

NOMINATIONS CLOSE:

At Federal Council - the Federal Executive election is the first item on the agenda of the annual meeting of the Federal Council.

CUT OFF DATE FOR ROLL:

Does not apply for this collegiate election.

FURTHER INFORMATION:

The Annual Meeting of Federal Council commences on Tuesday 1st June 2010 And we seek you assist us by organising a Returning Officer from the AUSTRALIAN ELECTORAL COMMISSION to attend our premises at 52 Buckingham St, Surry Hills on the above day at about 11:00am to conduct this ('collegiate') election.

Note: only the 17 Councillors may stand for office and only the 17 Councillors may vote.

It is normal practice for the election of Federal President be first, conducted so that a candidate failing to achieve that office may then nominate for another position.

Please note that following the election of three (3) Vice Presidents, we request the Returning Officer assist the Council in appointing one of these three to be Senior Vice President. We therefore request the Returning Officer make a further call for nominations from amongst these three to be Senior Vice President, and we seek assistance in conduct of an election, if necessary, to appoint one of these as "Senior Vice President" in accordance with Rule 10.

This statement is lodged in accordance with the previous requirements of the Workplace Relations Act and should this not conform with the requirements of the Fair Work (Registered Organisations) Act we seek the exercise of discretion allowed FWA in relation to any technical deficiency in this notification.
