Arrangement for conduct of election.

[1] On 3 April 2014 the Newcastle Branch of The Australian Institute of Marine and Power Engineers (the Branch) lodged with the Fair Work Commission (the Commission) the prescribed information in relation to an election for the following offices:

[2] On 22 April 2014 the Commission wrote to the Branch to inform them that under section 189(2) of the *Fair Work (Registered Organisations) Act 2009* (the Act) prescribed information must be lodged within such a time frame as to avoid delays in the election. On this occasion the prescribed information had not been lodged within a time frame that would allow all offices to be filled in accordance with the rules of the organisation or upon their expiry, and that a request for an extension of time would be required.

[3] On 22 April 2014 the Branch lodged a written request for an extension of time for lodgement in accordance with s.189(2) of the Act. The Branch Secretary apologised for not lodging the prescribed information sooner and stated that the delay in lodgement was due to an attempt to align the offices required to be elected into a single election.

[4] I allow for the extension of time up until 3 April 2014 to lodge the prescribed information.

[5] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

Scheduled Election - The Australian Institute of Marine and Power Engineers - Newcastle Branch (E2014/117)

I refer to the prescribed information dated 1 April 2014 which was lodged with the Fair Work Commission on 3 April 2014, for a scheduled election of offices of the Newcastle Branch of The Australian Institute of Marine and Power Engineers (the Branch).

The prescribed information included a request for an election of a Branch Treasurer in accordance with rule 32 of the Australian Institute of Marine and Power Engineers rulebook. The office of Branch Treasurer was declared elected on 1 May 2012 in matter E2012/215. The current term of office is therefore due to expire on 1 May 2014.

Rule 33B(iii) provides that notice specifying opening and closing dates for nominations is to be given by the Returning Officer at least one month prior to the date fixed for the election. For the office of Branch Treasurer, the requirement for the one month notice period will mean that the office will not be able to be filled by the date of expiry.

In addition, section 189(2) of the Act states that prescribed information must be lodged before the prescribed day, which under regulation 138(3) of the regulations is two months before the first day when a person may become a candidate. Section 189(2) is a civil penalty provision. While I acknowledge that there is as yet no set date for nominations to open, the intention of regulation 138(3) is to encourage prescribed information to be lodged early enough to avoid delays in the conduct of elections. For this reason the Delegate of the General Manager will require a written request for an extension of time and providing reasons why the prescribed information for the Branch Treasurer was not lodged at least one month prior to the expiry of the term of office.

On receipt of such request, the prescribed information will be forwarded to the Delegate of the General Manager for approval.
