#### Details:

#### Difficulty with rule 33B(v)

1. The requirement in rule 33B(v) to despatch postal vote packs to voters well ahead of the ballot opening risks a number of irregularities by voters returning ballots before the ballot has opened.

Despite the AEC giving appropriate instructions to the voters as to the correct timeframe in which the postal votes are to be returned, the risk remains that voters unintentionally returning the postal vote early gives rise to an irregularity that would disenfranchise the voter because the vote must be rejected. This occurred in election E2020/197 and E2020/94 where 10 and 4 ballot papers respectively were returned to the AEC before the ballot (period) opened and again in this election E2020/160 where 1 ballot paper was returned to the AEC before the ballot period opened.

The Returning Officer exercised the power provided by subparagraph 193(b)(ii) of the Fair Work (Registered Organisations) Act 2009 (the 'FW(RO) Act') to remedy the procedural defect that appears to exist in the AIMPE Rules mentioned above by deciding to admit postal votes returned prior to the ballot opening to the scrutiny.

The AEC's concern centres on the undesirability of resorting to exercising the remedial power provided by subparagraph 193(b)(ii) of the FW(RO) Act because timeframe for opening of the ballot is unnecessarily restrictive. The AEC understands that the early despatch of postal votes is intended to ensure voters have the fullest opportunity to receive their ballot papers, cast their vote and return their postal vote before the ballot closing time. The AEC believes that amending the AIMPE Rules to extend the ballot period by 14 days is the appropriate way to give effect to the intention behind.

2. As there is no rule pertaining to the withdrawal of Nomination, the Returning Officer has applied subparagraph 193(1) (b)(ii) of the Fair Work (Registered Organisation) Act 2009 to fix a closing time for the withdrawal of nomination and the withdrawal period was aligned with the close of the nomination period.

3. As there is no rule pertaining to the method of lodgement of Nomination, the Returning Officer has applied subparagraph 193(1) (b)(ii) of the Fair Work (Registered Organisation) Act 2009 and Nomination forms were instructed to be lodged by way of the AEC's Electoral Event Portal or emailed to IEBnominations@aec.gov.au. The Election Notice provided instructions about how to lodge nomination forms.

At least six months before the term of office(s) expires, the Branch Secretary shall lodge with the Registered Organisations Commission (ROC), the prescribed information relating to the election, as required by section 189(1) of the Fair Work (Registered Organisations) Act & regulation 138(3) of the Regulations. The Commissioner shall, when satisfied that an election is due to be held make arrangements for the conduct of the election by the Australian Electoral Commission (AEC). The prescribed information shall include:

the name and numbers of each office or position for which an election is due the reason for the election, being either:

o scheduled - the term of office has expired or is due to expire in the normal course of events; or o casual vacancy;

or lo insufficient nominations - an office or position was not filled at a previous election; or lo a new office or position has been created.

the electorate for the ballot the dates and times for the opening and closing of nominations the day provided for in the rules on which the roll of voters is to be closed the voting system to be used (direct voting system or collegiate electoral system), and any non-office positions for which an election is requested (section 187)."

Notice that nominations are required and specifying the opening and closing dates for nominations shall be given by the Returning Officer by publication in the Institute magazine "On Watch" and on the AIMPE website or by direct mailing to members' postal address at least one (1) month

before the date on which nominations open. The Nominations Period shall be for a period of six (6) weeks and the Voting Period shall also be, for a period of six (6) weeks. "

Each candidate shall complete and submit, a Nomination Form, available from either the AIMPE Branch, AIMPE website or the AEC."

Each candidate may submit a candidate statement, not exceeding 300 words, for inclusion with their ballot paper, should such ballot be held. The candidate statement shall be forwarded to the Returning Officer, no later than

seven (7) days prior to the date set for the commencement of the Voting Period."

Upon the closing of nominations, the Returning Officer shall determine whether and if so, which, of such nominations are in order and if more than the required number of nominations have been received and are in order, the Returning Officer shall conduct a secret postal ballot of the members of the Branch. Where the returning officer finds that a nomination is or may be defective, the returning officer shall, before rejecting the nomination, notify the person concerned of the defect and where practicable, give the person the opportunity of remedying the defect or providing further information in support of the nomination, within a period of not less than seven days after being notified. Where the returning officer has notified a person of a defective nomination, and where that person has remedied the defect and advised the returning officer within the time prescribed by the returning officer, the returning officer shall accept the nomination. Where the returning officer has notified a person of a nomination defect, and where that person has not corrected the defect and advised the returning officer within the time prescribed by the returning officer, the nomination shall be rejected."

The Returning Officer shall cause a ballot paper to be prepared, containing in alphabetical order, the names of the candidates so nominated and such directions as the Returning Officer shall deem fit, as to the marking of the votes. The ballot shall be regarded as open, as soon as the Returning Officer causes to be sent by prepaid mail, to each financial member of the Branch, a ballot paper together with two (2) envelopes, a "declaration envelope" with a removable flap or label and a prepaid envelope. Both envelopes must comply with the forms prescribed by the Fair Work (Registered Organisations) Regulations 2009. The Returning Officer shall also provide facilities for the return of completed ballot papers by the voter without expense to the voter."
