I acknowledge receipt of your letter dated 16 June 2014 in relation to the information that I included in my filing letter of 21 May 2014.

Although some organisations such as the Australian Municipal, Administrative, Clerical and Services Union (ASU) have previously lodged the information as branches, a number of organisations have lodged the return as a single entity. While the Fair Work Commission (the Commission) and its predecessors have, in the past, accepted documents from branches of organisations, it is clear that this is a responsibility that must be met by the organisation.

In respect to the ASU, I acknowledge that it is appropriate for those officers directly responsible for the keeping of the membership records to make the required declaration. Branches can continue to prepare separate declarations of the information but the information should then be lodged in conjunction with the declaration by the national office. As indicated above, the RO Act puts the onus on the organisation to lodge the information.


