Assistant National Secretaries (2)

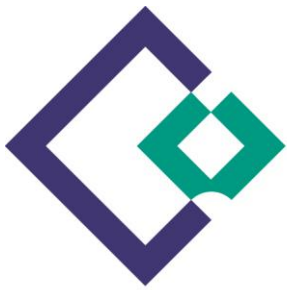

Offices/Positions

National President (Collegiate)
National Vice-President (Collegiate)
National Secretary (Collegiate)
Two Assistant National Secretaries (Collegiate and by proportional representation)

Reasons for the election:

Election for offices and positions is required as the terms of the office are due to expire in the normal course of events under the rules of the organisation.

Elected by:

The electorate for collegiate electoral system is by and from the National Executive being the Committee of Management in accordance with the rules (totalling 26 persons).

National Office/Position Nominations open:

ASU Rule 40(a) provides that the Returning Officer shall call for nominations for the above positions by notice in writing to all members of the National Executive on the Wednesday following the expiration of 28 days after the completion and declaration of all Branch elections for the offices of Branch National Executive representatives, or the first Wednesday in July, whichever is the earlier.

Branch elections in accordance with the rules are held prior to the National offices elections (see ASU Rules - Part XII Elections). Each Branch will notify you separately of their positions to be elected.

The timetable for Branch elected positions is as follows:

- Nominations for Branch Positions open the first Wednesday in March (4/3/15) ASU Rule 40 b.
- Nominations close 21 days after they are called (25/3/15) ASU Rule 40 d;
- The ballot opens no later than 28 days' after the close of nominations; ASU Rule 41 b;
- The ballot closes after 21 days ASU Rule 40 d and 41 b.

National Office/Position Nominations close:

Nominations shall close 21 days after they are called and the positions will be elected by collegiate elections.
