Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of Stage 1 and 2 uncontested and contested offices for the Queensland Together Branch [E2014/279]. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission **within 35 days of any changes** to the holders of office in the organisation. **If there are no changes a notification is not required.** If the election has resulted in **any changes** to the holders of office, the Australian Municipal, Administrative, Clerical and Services Union-Queensland Together Branch must notify the Commission of these changes. In particular, please advise:

1. Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.

2. Person(s) who have commenced to hold office:
 - the name of the office now held;
 - the date of the change of office holder;
 - the name of the person now holding the office;
 - the postal address of the person (generally the postal address of the organisation); and

 - the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

Rules difficult to apply/interpret:

STAGE 1 – 2015

Branch Rule 45d

Rule 45d directs that 'The Branch Industry Division Executive will, subject to this rule, determine when a Branch Industry Conference will be held.' Currently those positions are vacant. The Branch Secretary has advised that a rule change will be required.

Australian Electoral Commission

As a result of this rule the following positions remain vacant and the Returning Officer is unable to proceed with the election of these positions.

1. Branch Industry Division Executive Member (Public Service)
2. Branch Industry Division Executive Member (Public Health)
3. Branch Industry Division Executive Member (General)

STAGE 2 – 2017

The Together Branch Rules and ASU national rules were evolved from previous versions incorporating AEC feedback in 2015 – Latest iteration used for stage 2.

However the following points were noted by the DRO in 2017 in finalising 2 offices for this election and 5 offices for 2017/37 (concurrent election using the same rules) as areas where further clarity and simplicity was required.

1. National Rule 40.bii - Advertising:

DRO thought the wording was unclear in relation to differentiating quadrennial and collegiate elections via rule 31, and as then overarched by national rule 41e as read by an unfamiliar non-member, and the extent of the specified requirements to advertise and by what means/forms.

Together Branch replied: Rule 40 b ii refers to the advertising process for quadrennial elections. In this current election all the elections are collegiate elections with the relevant electoral colleges being defined in Rule 31 of the Branch rules. The electoral colleges are the relevant Branch Industry Divisions' Conference delegates. Rule 41 e of the ASU National rules covers collegiate elections and does not have a requirement to advertise in newspapers. To ensure all the members of the electoral colleges are notified of the election it is our intent to notify Branch conference delegates by email and post and to publish a notice on our Branch website.

DRO Determination: No impact in this case as additional 'advertising' was undertaken by the Branch (newspaper, website, emails).

2. National Rule 39 part VII and rule 40 part VII Nominees:

DRO could not readily conclude candidate nominator's criteria with regards to stipulation that 2 nominees are required for candidacy and then the eligibility criteria of those nominators please?

Together Branch replied: There was some discussion and debate over the requirement for a nominee to be nominated by 2 members of the Electoral College when we conducted the last round of collegiate elections (**Vacancy Election E2016/125 – Stage 2 Collegiate Election**). After submissions from our Branch and from the ASU National Secretary, the AEC previously concluded: *"Accordingly, I intend to apply the provisions contained in rule 39 in Part VII of the Rules to the eligibility of candidates, and rule 40 in Part VII of the Rules will apply to the nomination of candidates."*

DRO Determination: This determination was applied in this round also. The rule wording needs to better reflect the requirement for collegiate specific elections at Branch level, and free from contrary national statements.

3. National Rule 41e and Branch Rule 32c (noting National normally overarches branch)

DRO could not easily determine rulings regarding attendance or postal ballot requirements or options

Together Branch replied: Prefer that the ballot for filling the vacant positions on National Conference and Branch Council was conducted by postal ballot as soon as possible rather than waiting until the next meeting as per the national rule 41 e.

Branch Executive endorsed the provision in Branch Rule 32(c) for the election of Branch Council Delegate and National Conference Delegate to be conducted by way of secret postal ballot.

DRO Determination: This was accepted by the DRO on precedent of previous AEC rulings and secret postal applied for 2017/37. Suggest the Branch ruling be noted to overarch national at 32c.

4. Branch Rule 31a and Rule 33b

DRO could not easily determine if these offices being elected were 'casual vacancies', and who therefore was eligible to vote for the specified collegiate offices.

Together Branch replied: The Branch does not believe 'casual' applies to this current election, where approximately 400 Branch Conference delegate positions have 200 unfilled. Branch Conference delegates are elected directly by and from the members in sub-divisions. The Branch Conference delegate positions are those defined at lines 14-16 of the table in Rule 31 a. These are the casual vacancies that are referred to in Rule 33 b of the Branch rules. The positions in this current election are positions that are elected collegiately from the existing Branch Conference delegates (by Division). We will be undertaking a separate process in June to call for nominations to fill the directly elected Branch Conference positions that are currently unfilled. Branch Rule 31 a (bottom of the table) and Branch Rule 42e both state that the members of the Branch Industry Division executives will be elected by and from Branch Conference members attached to the Branch Industry Division.

DRO Determination: Accepted after escalation within AEC.

5. Branch Rule 41cii

DRO could not with any assurance determine if multiple nominations for more than one concurrent collegiate office, by particular college members was allowed.

Together Branch replied: They are entitled to do so and eligible, regardless of wording of 41ciii which appears contrary.

DRO Determination: After escalated advice sought within the AEC, it was determined that eligible members may nominate for more than one office within the same college as per this election.

6. National Rule 41.5.d.ix Strike out ballot papers versus place an 'X' next to candidate/s of choice ballot paper requirement

DRO suggests there is ambiguity and lack of clarity regarding 'strike out ballots' versus 'place an X' as specified by the Branch for these offices with multiple positions.

Australian Electoral Commission

Together Branch advised: 'Place an X' ballot paper rather than a 'strike out' ballot paper in accordance with rule 41.5.d.ix on page 78 preferred.

DRO Determination: 'X' mark ballot used rather than strikeout (as 41.e.ix is not applicable to the Together Branch as not listed in 41.d on page 78 of the national rules). Because Together Branch is not listed at 41d, it was deemed 41e ix is not applicable and 41 x applies.

Roll of Voters

STAGE 1 – 2015

The roll of voters provided by the organisation consisted of **24942 members**.

279 Non-current addresses were noted (Members where no postal address provided). The Returning Officer contacted the Secretary to obtain these address details. In response address details for a further 2 members were provided and the Secretary advised in regard to the remaining members with no address "we have had mail returned from them with address unknown".

370 work addresses were noted

STAGE 2 – 2017

The roll of voters provided by the organisation consisted of **192 members** across 7 Colleges; 2 of these Colleges related to 2014/279 and 5 related to the concurrent 2017/37. The total for 2014/279 specifically was **88 Members**.

0 Non-current addresses were noted

2 work addresses were noted

2 Roll of voters for 2 potential remaining 2014/279 Elections were received totalling 88 members - 43 voters for Branch Industry Division Executive (General) and 45 voters for Branch Industry Division Executive (Public Health).

Irregularities

STAGE 1 – 2015

Two separate complaints were received regarding the conduct of the election. These were from:

Australian Electoral Commission

Mr Denis Auberson who raised concerns about member funds being used to support election activities of a candidate. The details of the complaint were referred directly to Fair Work Commission approximately 30 April 2015

The second complaint was from Mr Tony Collins who raised concerns regarding a number of member records that did not include an address. Details of this matter are covered under the heading above (ROLL OF VOTERS). Mr Collins also raised an issue on behalf of another member Mr Ian Hanks. Mr Hanks did not receive his ballot papers at the time that others received theirs. He contacted the ASU to be informed that his address had not been forwarded to the AEC as he had previously requested that the union not post anything to him. The member contacted the returning officer and he was provided with his ballot material in time to be included in the ballot.
